**Flag Salute:** The flag salute was led by Kathy Smith.

**Review of previous month's minutes:** The minutes of the July 2009 meeting were approved as written, after corrections were made during previous review by the board. Motion to approve made by John Aziz. Motion seconded by Joyce Harrison. Motion passed 7/0.
