San Bernardino National Forest (Lauren Blake via email): Continue to work on Boa prescribed burn project. The actual burn is approximately one year away. Staffing levels are good.

Cal Fire: Discussed grants currently being applied for to fund continued hazardous tree efforts.

LA County Fire: No report.

SB County Fire (Mark Wright): June 2014 stats: 65 total calls, including 34 to Wrightwood, 13 to Phelan, 14 to Pinon Hills and 4 to LA County. September 24, 2014 station 14 will be adding another person to staff their engine.

SB County Code Enforcement: No report. John Aziz indicated that they are still working on locating a demo house for 2014.

LA County Agricultural Commission: No report.
