**Meeting Minutes**

**Call to order:** The general meeting for the Wrightwood Fire Safe Council (WFSC) was called to order by John Bauer on May 19, 2015 at 1900 hours local time, at 6000 Cedar, Wrightwood, CA 92397.

**Roll call:** The following WFSC Board of Directors were present: John Aziz, John Bauer, Chuck Carroll, Robert Comperini, Jim Emery, Glenn Goldstein, Bruce LaClaire, Kathy Smith. Absent was: Hank Hallmark, Al Morrissette.

The following agency representatives were present: Wesley Anzai (LA County Fire), Jeff Birchfield (SB County Fire), Lauren Blake (San Bernardino National Forest), Debbie Chapman (Cal Fire), Matt Edmiston (Cal Fire), Mary Stock (CalFire), Joe Zuccaro (SB County Fire).

**Flag salute:** The flag salute was led by Chuck Carroll.

**Green waste event:** John Aziz discussed the upcoming green waste event. The FSC is soliciting volunteers to work the event.

**Public comments and questions:**

Shawn Troeger discussed recent activities with the San Gabriel Mountains National Monument Community Collaborative. This collaborative is a group of interested parties gathered together to represent the general public with the U.S. Forest Service to help define how the Monument and Forest will be managed and operated. Tracy is acting as the Wrightwood representative on this group. She discussed various documents and plans will be released soon, for public comment.

**Approval of minutes:** The minutes of the April 21, 2015 meeting were approved as written. A motion to approve was made by John Aziz. Motion seconded by Bruce LaClaire. Motion passed 7/0. Robert Comperini abstained.

**Cooperative partner & agency updates:**

Angeles National Forest: No report.

San Bernardino National Forest (Lauren Blake): Seasonal fire staffing has begun. Training is taking place. No major fuel modification projects in the near future.

Cal Fire (Mary Stock): Fully staffed for fire season. Training for various staff positions is taking place. They are seeing an increase in dead trees in the Crestline/Pilot Rock area.

LA County Fire (Wesley Anzai): Staffing is at full level for fire season. Three helicopters are staffed and available.

SB County Fire (Jeff Birchfield): April 2015 statistics: 65 total calls, including 18 in Wrightwood, 19 to Phelan, 26 to Pinon Hills and 2 to LA county. Joe Zuccaro discussed the wood shake shingle roofs,

and the new regulations regarding them. When more than 10% of the roof is replaced, the entire roof must be replaced. There is no grant money available to help with these replacements.

SB County Code Enforcement: No report.

LA County Agricultural Commission: No report.

**Treasurer's report:** No treasurer's report was submitted, since there was no activity during the last month.

**Adjournment:** The meeting was adjourned at 1958 hours local time. The next general WFSC meeting will be held on June 16, 2015.
