**Meeting Minutes**

**Call to order:** The general meeting for the Wrightwood Fire Safe Council (WFSC) was called to order by John Bauer on 10/18/2016 at 1900 hours local time, at the 6000 Cedar, Wrightwood, CA 92397.

**Flag salute:** The flag salute was led by Jim Emery.

**Public comments:** Chuck Carroll mentioned that the recent hazmat event was a huge success. Jim Galvan, with the California Conservation Corp announced a fuel reduction project. He has 8473 hours to use before 6/30/2017. This project will begin around the second week of December 2016. Area to be treated is the area along SR-2 between Sheep Creek and Wright Mountain roads.

**Cooperative partner & agency updates:**

Angeles National Forest (via John Aziz): John briefly discussed the management changes going on in the Forest.

San Bernardino National Forest: No report

Cal Fire (Mark Stock): Still in fire season. Red flag alert in effect. Some equipment being relocated back to southern California, from northern California fires. Inmate crew staffing has not been changing.

LA County Fire (Kurt Shaefer): LA County Fire is also getting prepared for the red flag alert this week. Briefly discussed helicopter support they normally order for brush fires.

SB County Fire (Kelly Anderson): Stats: 285 calls for service between station 10 and 14. Small Business Administration was available to give loans to victims of Blue Cut fire.

SB County OES (Miles Wagner): Work continues on the hazard mitigation plan update. County is also helping victims of the Blue Cut fire. "Shake out" earthquake drill will be held October 20, 2016. CERT will be involved.

SB County Code Enforcement: No report.
