California Climate Investments (CCI) Grant: \$3,960,656 Grant applied for that includes Approximately 1,100 Federal and 450 SRA acres. Proposed grant includes fuels reductions in and around the community of Wrightwood. WFSC partnering with ANF, LA County Fire, SB County Fire and CAL FIRE.

Funding Opportunity- California Conservation Corps (CCC): \$173,000 (5000 hours) awarded to the CCC through Prop 68, currently looking for projects in the area.
